**Class One:** Chipping and Putting Review (and how the Grain can affect these shots) and Driving Range- Checking the fundamentals. **Class Two:** Pitching the Ball (basic pitch/ Lob Shot/Flop Shot) and Range: Learning to practice our Yardages. **Class Three:** On-course play learning to compute the yardages (using wind, elevation change/Grain influence/Lies- rough vs. fairway). **Class Four:** Choosing the correct shot to play (chip/pitch/Lob/Flop) factoring in grain, lie, slope, wind, etc. and Range: Swing Mechanics and Developing or improving our Routine, and improving our Tee Ball (Driving). **Class Five:** On-course play learning to manage our Game (Play to our strengths), dealing with un-even lies (uphill, downhill, ball below our feet, ball above our feet)
